In a special school, this may include complex medical needs.</li> </ul> <p><b>Support for the Teacher</b></p> <ul style="list-style-type: none"> <li>- To assist in the monitoring/recording of pupil progress and developmental needs.</li> <li>- To assist in the production of learning resources.</li> <li>- To undertake routine classroom administrative tasks including the maintenance of records.</li> <li>- To assist in pupil supervision and assist in the management of pupil behaviour.</li> <li>- To provide information to the class teacher to assist in the planning of work programmes.</li> <li>- To liaise with the school's nominated person in respect of pupil absence.</li> <li>- To assist with the arrangements for out of school learning activities including the administration of work experience.</li> <li>- To provide clerical and administrative support including the collection and recording of money.</li> <li>- Administer routine tests, assist in the invigilation of exams and undertake routine marking of pupils' work</li> </ul>
